General Terms of Use

SHIPCOTRANSPORT.EFSTMS.COM, TMS.SHIPCO.COM or any customized version thereof (hereafter known as Shipco Transport TMS).

Your viewing or use of this site will constitute your agreement, on behalf of yourself and the entity you represent (hereinafter collectively "you" or "your"), to all of the terms and conditions provided below.

Shipco Transport TMS is the sole and exclusive property of Shipco Transport, Inc. Any of the content included on this site such as text, images, trademarks and names, and all other features, software and functions, belong to, or have been licensed to, Shipco Transport, Inc., for its sole use and the use of its customers under the Terms and Conditions set forth herein.

Shipco may make future changes or modification to such terms and conditions at any time without notice and your subsequent viewing or use of Shipco Transport TMS will constitute your agreement to the changes and modifications. There may be additional terms and conditions provided throughout Shipco Transport TMS governing your use of particular functions, features, information and applications available through Shipco Transport TMS. Use of Shipco Transport TMS is provided solely for the use of current and potential Shipco customers to interact with Shipco and may not be used by any other person or entity, or for any other purpose.

Specifically, all tracking, rating, drop-off and other information may only be used by current and potential Shipco customers. The use of automated dial-in or inquiry devices to obtain information through Shipco Transport TMS is strictly prohibited.

Shipco does not accept ideas, concepts, or techniques for new services or products through Shipco Transport TMS. If such information is received, it will not be considered confidential and Shipco will be deemed free to use, communicate and exploit such information in any manner it chooses.

Shipco Transport TMS Registration

By using Shipco Transport TMS, you agree to provide accurate and current information about yourself as prompted by the Shipco Transport TMS and maintain and promptly update your profile information to keep it accurate and current.

If you provide any information that is inaccurate or not current, or Shipco has reasonable grounds to suspect that such information is inaccurate or not current, Shipco has the right to suspend or terminate your Shipco Transport TMS registration. By registering with Shipco Transport TMS, you will receive a user I.D. and password. That can be changed under 'Manage Accounts'. You are responsible for maintaining the confidentiality of the password and user I.D., and you are responsible for all activities that occur under your password and user I.D. You agree to (a) immediately notify Shipco of any unauthorized use of your user I.D. and password, and (b) ensure that you exit from your Shipco Transport TMS session at the end of each visit.

Changes to Shipco Transport TMS and its content, including without limitation the information, graphics, products, features, functionality, services, and links (collectively the "content") may be changed, deleted or updated without notice.

Terms

Shipco may discontinue, suspend or modify Shipco Transport TMS any time without notice, and Shipco may block, terminate or suspend your and any user's access to Shipco Transport TMS at any time for any reason in its sole discretion, even if access continues to be allowed to others. Indemnity

You hereby release, and agree to indemnify and hold harmless Shipco Corporation and its subsidiary corporations and their respective officers, directors, employees and agents from any and all claims,

demands, causes of actions, liabilities, damages, costs and expenses, including reasonable attorneys' fees, arising out of your use or viewing of Shipco Transport TMS and its content.

TSA Approved Truck Carriers

Certain services are offered through truck carriers who may operate in accordance with TSA IAC standards. When shipments are booked through Shipco Transport TMS with any such carrier, Shipco Transport shall not be deemed an Authorized Representative as defined in TSA Indirect Air Carrier Standard Security Program (IACSSP). It is the sole responsibility of the customer to establish such an agreement with the truck carrier directly.

If a pick-up is booked through Shipco Airfreight AND Shipco Airfreight is handling the airfreight shipment through to destination, the transaction will be carried out under Shipco Airfreight's IACCSP.

Controlling Law and Severability

This Agreement may not be changed or modified without the written consent of Shipco.

Rates

Any and all rates quoted are subject to change and final verification. All inland transportation rates are estimated and are subject to change and final verification with the inland transportation service provider.

Confidentiality

In connection with the Customer's access to information via the internet, intranet, extranet, and Shipco Transport TMS (collectively known as the "proprietary information"), the Customer acknowledges the proprietary and confidential nature of the proprietary information. Customer agrees during and after the term of their business relationship with Shipco not to disclose to anyone or make use in any way of the proprietary information except as required in line with duties regarding said relationship with Shipco or pursuant to written permission from Shipco to do so. Customer also agrees that access to the proprietary information is granted to his company and employees thereof by Shipco for business purposes only linked to the business relationship with Shipco and that Customer's use of such systems may be monitored at Shipco's discretion. Customer may not use such resources for personal business and may not copy or any of the proprietary information. Customer is obligated to give Shipco a list of employees to whom Customer has allowed access to proprietary information. Customer is further obligated to notify Shipco immediately of any change to this list. Customer is furthermore obligated to assign one login and one password per user. These should under no circumstances be distributed nor shared between the staff. Login and password are strictly for individual use only. Client is ultimately responsible to ensure that employees nominated by the Customer to have access to proprietary information comply as per the above.
